**ORDER OF ELECTION OF HUNT MEMORIAL
HOSPITAL DISTRICT
(ORDEN DE ELECCIONES DEL DISTRITO CONMEMORATIVO
DEL HOSPITAL DE HUNT)**

An election is hereby ordered to be held on May 4, 2024 for the purpose of electing two hospital directors from each of Commissioner's Precincts One and Three, one hospital director from Commissioner's Precinct Two, and one hospital director At-Large in Hunt County.


In the event two persons or less per Commissioner's Precinct apply for candidacy for the positions on the Board of Directors of HUNT MEMORIAL HOSPITAL DISTRICT from either or both of Commissioner's Precincts Numbers One and Three of Hunt County, Texas and/or only one person applies for candidacy for the unexpired position on the Board of Directors of HUNT MEMORIAL HOSPITAL DISTRICT from Precinct Two and only one person applies for candidacy for the position on the Board of Directors of HUNT MEMORIAL HOSPITAL DISTRICT At- Large, then HUNT MEMORIAL HOSPITAL DISTRICT shall certify that said candidates are unopposed pursuant to Section 2.051, et. seq. of the Texas Election Code and said candidates will be elected by order of the Board of Directors of HUNT MEMORIAL HOSPITAL DISTRICT. In that event, no election will be held for the unopposed offices.

(En el caso de que dos personas o menos por Precinto del Comisionado soliciten la candidatura para los puestos en la Junta Directiva de HUNT MEMORIAL HOSPITAL DISTRICT de uno o ambos Precintos del Comisionado Números Uno y Tres del Condado de Hunt, Texas y/o solo una persona solicite candidatura para el puesto en la Junta Directiva de HUNT MEMORIAL HOSPITAL DISTRICT del Precinto Dos y solo una persona solicita la candidatura para el puesto restante en la Junta Directiva de HUNT MEMORIAL HOSPITAL DISTRICT At-Large, entonces HUNT MEMORIAL HOSPITAL DISTRICT certificará que dicho los candidatos no tienen oposición de conformidad con la Sección 2.051, et. siguiente del Código Electoral de Texas y dichos candidatos serán elegidos por orden de la Junta Directiva de HUNT MEMORIAL HOSPITAL DISTRICT. En ese caso, no se llevarán a cabo elecciones para los cargos sin oposición.






